Box 3711), Montgomery, Alabama, until 2:00 p.m., CDT, Thursday, 21 July 2011, for the South Region Indoor Firing Range Conversions to Storage AL – ARNG Readiness Centers – Brantley, Hartford, and Florala, AL (IFB# AC-11-B-0006-S) AL ARNG Project Numbers: 0111013, 0111014, and 0111015 at which time they will be publicly opened and read in the Second Floor Classroom (Room 201), of the State Military Department, 1720 Cong. W.L. Dickinson Drive, Montgomery, Alabama.
